Let a rule nisi be issued calling upon the respondent Nos. 1 to 6 to show cause as to there in action to take appropriate action against the respondent No. 7 on the incident reported in the Daily News paper Brothom Alo dated 10.1.2010 Annexure-A and immediately report to the this Court within 24 hours with regard the their actions and measures taken on the incident (Annexure-A) and direct the respondent nos. 4 to 6 to send the victim Hosne Ara immediately for treatment to nearest one stop Crisis Center at Khulna/Barisal and/of such other or further order or orders passed as to this court may seem fit and proper.

Pending hearing of the rule, the Respondent Nos. 4,5 and 6 are directed to take immediate steps ensuring safety victim Hosne Ara and arranging for her treatment.

The Rule is made returnable within 4(four) weeks from date.


The Petitioner is directed to put in requisites for service of notices upon the respondents in usual course and through registered post.


